

This book Roberts Rules: QuickStart Guide is similar to other books from this publisher, it spends no time on frivolous matters but gets right to the point. This is a very quick read, but not because it doesn't contain a lot of information but rather because it condenses down only the important information to be presented to the reader. This book has only six chapters: Chapter 1 â " setting up for success using Roberts rulesChapter 2 â " building your bylawsChapter 3 â " making the most of your meetingsChapter 4 â " the art of the motionChapter 5 â " ways to create great committeesChapter 6 a " sample of parliamentary procedurel will say there were some minor issues with formatting on the screen on my Kindle version, but nothing too severe. For those that don't know Robert's Rules is the title of a book written by Henry Martyn Robert in 1876 that has been through 11 editions since then. The idea is to make a group of rules to govern how a group of people should make decisions and how they should efficiently run meetings. The rules are very loosely based on the procedures of the US House of Representatives. The current, 11th edition, was published in 2011 and is 716 pages in length. So it's not exactly a quick read, but this book is and it accurately gives you the gist of what is in the full volume. This is useful for every type of organization from educational groups to homeowners associations to trade unions to student government, etc. The main idea is that each member of the group has an equal vote whenever a choice is being made and the choice is always majority rule, unless otherwise specified in the bylaws of the organization. I found it particularly useful for giving a good outline of how to run a proper meeting.
